



Sandwich panels (PUR & PIR) market share* in 2018:





TERASTEEL DOO SERBIA



June 2017

- TeraPlast Group buys a Serbian factory of sandwich panels from
 Interlemind → EUR 4.8 million investment
- •TeraSteel **doubles its production capacity** of thermal insulation panels with a line similar to the one at Bistriţa (production capacity 2.2 mil. sqm.)

October 2017

- TeraSteel starts producing in Serbia through the new company
 TeraSteel DOO, located in Leskovac
- TeraSteel DOO becomes **the first factory inaugurated abroad** after 1990, which is fully owned by a Romanian company

2018

After a **EUR 1 million investment**, TeraSteel Serbia started the production of self-supporting trapezoidal sheet and thermal insulating panels with mineral wool. After just one year of activity, TeraSteel Serbia is one of the main suppliers of sandwich panels on the CEE market.

Strategic move to obtain a competitive advantage on the CEE market

Our presence in Serbia allows us to reduce the costs of transportation without affecting the profitability margin, by accessing an over EUR 595 million or 31.3 million sqm panels market in the CEE

- •In terms of logistics, the sandwich panels are large-sized products, **hard to transport** and profitable for a successful trading on an area of
 maximum 400 km from a transportation costs perspective
- •Our factory is located near the highway connecting Albania to the West of Europe, thus facilitating **the access to the EU**
- •In case of **Bulgaria** the most disadvantaged market so far in terms of transportation costs the ratio goes down from 10% to 3.5%, offering us the chance to be much more competitive on the market

Advantages of investing in TeraSteel DOO

TeraSteel consolidates its position of a major player in the area

- •Facilities offered by the Serbian government, among which: buying lands within the city area at fixed prices, subsidies for creating new jobs
- Possibility of accessing **European funds i**n the next 10 years
- •More accessible **workforce** as compared to Romania (TRS-SRB average gross wage is 30% lower than in the case of TRS-RO)

TeraSteel **encourages performance** in sports and education, and therefore is constantly involved into actions in these fields.


Moreover, the company sustains the initiatives of the local community where it develops its activity, by long term partnerships.



TERAPLAST GROUP IN Q3 2019



TeraPlast Group registered a **22% increase in turnover** in the first nine months of 2019, up to 151.4 mil EUR. At the same time, the Group **EBITDA rose by 29%** compared to the first nine months of 2018, up to over 14 mil EUR. The results reached the top in the Group's history in terms of both profitability and sales, thanks to the construction market dynamics, the operational efficiency measures and strengthening the market shares.
